The Joint Committee on Printing, created by the act of August 3, 1846 (9 Stat. 114; 44 U.S.C. 101), is one of the oldest joint committees of the Congress. Composed of five Representatives and five Senators, the panel oversees the operations of the U.S. Government Publishing Office (GPO), whose support is essential to the legislative process of the Congress.

Joint Committee on Housing

JCAR is composed of 12 legislators who are appointed by the legislative leadership, with the membership apportioned equally between the two houses and the two political parties. It is co-chaired by 2 members representing each party and each legislative house. Support services for the committee are provided by the JCAR staff.

Joint committees include members from both houses of Congress, Parliament, or any ruling body. They focus on a particular issue, such as economics or taxation. They enhance communication between the two bodies. The committee's leadership usually alternates between the two bodies, as well.

Throughout the year, the JBC holds a number of meetings and considers a range of documents to help prepare budget recommendations for the General Assembly.

Johnson (a former member of the joint committee), and their cabinets, complied with committee requests for meetings and access to information.
